**Considérant** qu'en raison d'un **emménagement**, exécuté par la Société DEMENAGEMENT FOURQUIE - STT, domiciliée au 43 avenue du Bac - 94210 SAINT-MAUR-DES-FOSSÉS - Tél : 01.46.72.65.52, il y a lieu de modifier provisoirement les dispositions de stationnement, **avenue Foch, le 05 janvier 2026.**

### ARRETE

**ARTICLE I** : Le stationnement des véhicules de toute nature sera interdit et considéré gênant, **avenue Foch, au droit du n°142 sur 2 emplacements, le 05 janvier 2026**, afin de permettre aux camions et matériel de l'entreprise de stationner au plus près du lieu d'intervention.

**ARTICLE II** : Le présent arrêté sera affiché **48h00** avant le début du déménagement, si les places de stationnement réservées sont situées hors zone bleue, **7 jours** avant le début du déménagement, si les places de stationnement réservées sont situées en **ZONE BLEUE**. Les interdictions de stationnement seront matérialisées par des panneaux réglementaires mis en place par les Services Techniques Municipaux. La Société DEMENAGEMENTS FOURQUIE - STT, restera responsable de leur maintien en bon état de visibilité.

**ARTICLE III** : Toute utilisation d'un appareil de levage, de type monte meuble ou autre, devra nécessiter l'installation d'une structure permettant aux piétons un passage sécurisé sous ce dispositif. Une signalisation spécifique devra avertir les piétons de ce dispositif. Le demandeur restera responsable de cette installation.

**ARTICLE FINAL** : Madame la Commissaire de Police ou son représentant, Monsieur le Directeur Général des Services de la Mairie, Madame la responsable de la Police Municipale, sont chargés, chacun en ce qui le concerne, de faire respecter les dispositions du présent arrêté.

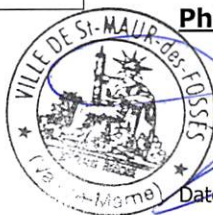
